# MINUTES OF MEETING OF THE FIFTH BOARD OF DIRECTOR'S MEETING

Conducted from 11-12 May 2015 at Deakin University City Campus, Melbourne Australia

#### 1.0 HOST WELCOMING SPEECH

The meeting was started at 9:05 am, Melbourne time. It was officially opened by Prof. Dato' Dr. Zakaria Kasa, the President of CAPEU. Then the President requested that Prof. Dr. Ian Robottom, the Deputy Dean for International Relations of the Faculty of Education of Deakin University to give few words regarding the meeting as the host for the Sixth BoD of CAPEU. Prof. Robottom welcame all the guests of honour from all members from all member countries. He said that will be retiring by this coming July 2015. However, after talking to the Dean of the Faculty of Education and other related key positions at Deakin University, he is still willing to serve CAPEU if he is needed.

He introduced Assoc. Prof. Dr. Christ, the Associate Dean for Research of the Faculty of Education of Deakin University. Then, he asked Dr. Christ to say a few words before all members of delegate from member countries. Dr. Christ said that the CAPEU flat form will be a good venue to develop research collaboration between members from different countries. This collaboration will enrich the quality of teaching, research and community engagement in education. He will be happy to work with all members of CAPEU in the areas of:

- (1) Exchange training in research methodology
- (2) Develop research partnerships among members
- (3) Global exchange of students between members of CAPEU
- (4) Develop reciprocal sabbatical leaves among members
- (5) Other programs that may be proposed by one or more members.

#### 2.0 CHAIRMAN'S WELCOMING SPEECH

Right after the speech made by Dr. Christ, The President of CAPEU addressed his Welcoming Speech in front of all heads of delegations of members of CAPEU. He said that the first few months of the first year of CAPEU (May-August 2013), no programs were executed due to not having any funds from members. Then, he asked the Secretary of BoD of CAPEU to give a full report of all activities that have been conducted by CAPEU from September 2013 to the present. The Secretary of CAPEU said that the First Program of CAPEU was an International Conference on Special Education held at Syiah Kuala University in Banda Aceh. She said that the Government of Aceh had helped CAPEU in conducting the conference. Several donors in Aceh also assisted CAPEU in conducting the conference.

#### 3.0 IMPROVE BETTER COMMUNICATION AND PROMOTION OF CAPEU

#### 3.1 IMPROVE BETTER COMMUNICATION

Prof. Dato' Dr. Noraini Idris, the Secretary of BoD of CAPEU, presented her reports to all members of CAPEU. She notified one by one all members that attended the Fifth BoD at Deakin University. The first request from her was to develop better communication between members of CAPEU and kindly requested the members to give name cards so that the Secretariat of CAPEU can communicate better with all members. She mentioned that several members cannot come to the meeting due to not having visas to enter Australia, especially the members from Indonesia. The followings are some of the comments from members regarding communication.

- 1). Prof. Dr. Mohd. Izam from UUM kindly requested that the Secretariat of CAPEU write proper name for leaders of each member. The title of the president/rector/chancellor/vice chancellor of each member must be properly addressed. The Vice Chancellor of UUM is not Prof. Dr. Dato' Sri but Prof. Dr. Dato' Wira. Some individual might be sensitive to the titles.
- 2). Prof. Izam also said that the name of his university should not be translated into English but to maintain as the original name of his university UUM (Universiti Utara Malaysia, and not Northern Malaysian University.
- 3). Dr. Hj. Adenan bin Hj. Basar, from KUPU-SB said that the proper name of the KUPU is the Kolej Universiti Perguruan Ugama Seri Begawan (KUPU-SB) and not the Kolej Universiti Perguruan Ugama Bandar Seri Begawan. Seri Begawan is the name of the father of the Sultan Hasanul Bolkiah. It is sensitive for the people in Brunei.
- 4). Prof. Ari Purbayanto, Indonesian Education Attache suggested that a "Mailing List" be developed and it will be easy for everyone in communicating with the Secretary of BOD and the Secretariat of CAPEU. He said he can assist CAPEU when communicating with members in Indonesia.
- 5). President of CAPEU asked the Secretariat and the Treasurer of CAPEU to develop the systems and start inserting all information of CAPEU in the web site.
- 6). Prof. Mohd. Izam of UUM suggested that communication should be to both, the President of each member and to those assigned to take care of CAPEU at each member. Each member should identify one or more contact persons.

#### 3.2 PROMOTING CAPEU

The President of CAPEU suggested that the Secretary of BOD, the Secretariat of CAPEU and himself to promote CAPEU to other colleagues within his country or overseas, anyone that you know. He said that CAPEU can be promoted to all members of The Association of Asia Education University Presidents where he is also in charge of its management. He knows the president of Education University of Hong Kong, several presidents of education universities in Korea and also Japan. Please expand it to any close colleagues of the presidents/rectors that attended the meeting today and also to other rectors/presidents that are not attending today. Regarding this request, the followings are several additional comments from the floor:

- 1). Prof. Dr. Mohd. Izam from UUM; kindly request that CAPEU Secretariat prepares standard flyers of CAPEU and sends them to universities of current member countries and also to new members in new countries.
- 2). Dr. Hj. Adenan bin Hj. Basar, Deputy Ra'es of KUPU-SB, proposed that the Secretariat sends a proposal to Brunei Institute of Education (BIE) to be a member of CAPEU.
- 3). The President of Philippines Normal University suggested that a proposal should be sent to several other education/normal universities in the Philippines. She specifically mentioned the Mindanau Normal University as it is a normal university in Muslim dominated areas in the Philippines. Please invite them to join CAPEU.

#### 4.0 APPROVAL OF THE FIFTH BOD OF CAPEU AT KUPU-SB

The President of CAPEU moved to the next agenda, that was the approval of the Fifth BOD Meeting at KUPU-SB in Brunei Darussalam. The Secretary of the BoD of CAPEU asked the members to raise their hands if they had any comments on the Fifth BoD of CAPEU in KUPU-SB. All delegates approved the last BoD of CAPEU in Brunei Darussalam.

#### 5.0 CAPEU JOURNAL OF EDUCATION

The President of CAPEU asked the Secretariat to report about the progress of the journal. The Secretary of the BOD of CAPEU reported that the journal was prepared by a team led by Prof. Robottom, Dr. Kway, Assoc. Prof. Dr. Rosnidar Mansor and the Secretariat of CAPEU (Qismullah Yusuf). The Secretary of BoD of CAPEU asked the Chief Editor, Prof. Robottom, to give reports on the progress of the journal.

- 1). Prof. Robottom proudly showed the new journal to be published, as soon as the ISBN is available, it will be ready online and be able to send hard copy to each member.
- 2). It will be available in the forms of hard copy and also online. The question is "who will print it and who wil also pay for the cost of printing and mailing.
- 3). Prof. Dr. Noor Shah Saad said that Dr. Kway has already received the ISBN Numbers and will send to Prof. Robottom as soon as possible.

- 4). As for printing the hard copies of the journal to be sent to all members, Prof. Noor Shah said that the cost will be paid by the CAPEU. Each university library of member of CAPEU will be sent one or two copies. Others will be available on line.
- 5). The President of CAPEU said that KUPU-SB should collect all good papers from the Second Conference of CAPEU and also published in the next journal.
- 6). Prof. Dr. Fuad Abdul Hamid from UPI Bandung said that all papers from UPI-UPSI Conferences can also be selected and published in this journal, in addition to its own UPI-UPSI journal, especially those written in English.
- 7). Prof. Robottom supported the ideas and added that the researchers conducted by Ph.D students of Deakin University who had presented their papers at Geelong and at UPSI can also be selected and published in this CAPEU Journal for the next edition.
- 8). President of CAPEU proposed that Prof. Robottom starts selecting best papers from UPSI-Deakin Symposium I and Symposium II and edit them to be published in the next CAPEU Education Journal.
- 9). Prof. Robottom said that there should be a standardized format, quality and also core areas for each publication.

#### 6.0 RECIPROCAL PROGRAMS

Secretary of BoD of CAPEU requested the Secretariat of CAPEU to make a full report of all reciprocal programs between members. She also asked each member who attended the Program Mapping Workshop at UPSI to implement what they have already agreed upon in the last workshop and report all activities to the Secretariat of CAPEU for documentation. In brief, she reported the following activities:

- 1). Reciprocal program between Syiah Kuala and UPSI on training of Disaster Management.
- 2). Reciprocal program between lab schools of Syiah Kuala University, consisting of:
  - 1). SMA Modal Bangsa
  - 2). Fatih Boy High School of Banda Aceh
  - 3). Fatih Girl High School of Banda Aceh
  - 4). Fajar Harapan Banda Aceh
  - 5). Lab School of Syiah Kuala

With the Kuala Kubu Bharu MARA High School, Selangor, a partner school of FPPM UPSI.

- 3). Reciprocal Sabbatical Leave between Syiah Kuala and UPSI
  - 1). Dr. Ikhsan was sent to Syiah Kuala
- 4). Dr. Goh and Dr. Siti Eshah were sent to Deakin and several of Deakin Staff will be sent to UPSI soon.
- 5). The Secretary of BoD of CAPEU also urged Prof. Noor Shah Saad (Director PULAMI of UPSI) to actively engage with other members of CAPEU in students exchanges for teaching practices and other related activities.
- 6). Prof. Ari Purbayanto, Indonesian Education Attache of Indonesian Embassy in Kuala Lumpur said that he will be happy to assist all members in developing contacts with Indonesian universities for students exchanges.

- 7). Prof. Noor Shah reported that PULAMI has developed an MoU and to be signed with several Indonesian members in collaboration with Prof. Ari at Indonesian Embassy.
- 8). Prof. Mohd. Izam from UUM proposed that all education attaches from member countries should be involved in developing reciprocal programs for student and faculty exchanges and also for teaching practices.
- 9). President of CAPEU suggested that members not only exchange programs reciprocally but also develop joint supervisors/co-supervisors for Ph.D program between members.
- 10). In addition to co-supervisor, there should also be co- or joint researches between members to enrich the program.
- 11). He also said that an exchange in Quality Teacher Training program should be developed between members of CAPEU. He proposed that Deakin University assists CAPEU in developing quality of teacher training.
- 12). He also suggested that CAPEU to contact NIE in Singapore, Hong Kong University of Education, Japan (Miyagi Education University) and OTHER LEADING INSTITUTIONS to have a special Roundtable Meeting.
- 13). The treasurer of CAPEU also suggested that members develop faculty and students exchanges with any members as had been agreed in the Program Mapping and inform the Secretariat to execute the program, such as UIA KUPU-SB and Fatony University symposium. He assigned the Secretariat to coordinate.
- 14). The President of Philippine Normal University (PNU) asked the President of CAPEU on how to develop Sabbatical Leaves for her staff at PNU and other faculty from other members to PNU. The President of CAPEU suggested that she develops contacts with the Secretariat of CAPEU.
- 15). Secretary of BoD of CAPEU suggested that each member also identify the areas for Sabbatical and it will help the Secretariat to contact partners of CAPEU: East-West Center, DAAD, Miyagi and also Deakin University. She suggested that Secretariat to seek more partners and develop more programs.
- 16). One very important message was proposed by the Treasurer of CAPEU and Secretariat of CAPEU that each university member **MUST** have a program to be exchanged reciprocally with other member within CAPEU and the program must be **approved** by the senate of each member prior to conducting negotiation in executing the program.

### 7.0 TRAINING PROGRAM OF CAPEU

The meeting moved to the Training Program of CAPEU.

- 1). Secretary of CAPEU assigned the Secretariat of CAPEU to develop a variety of trainings that are beneficial to all members:
- 2). The Secretariat proposed that:
  - (i) TESOL/TEFEL be conducted this year in collaboration with USA Education and be conducted at one of the members in Indonesia.
  - (ii) Thinking-Based Teaching and learning in collaboration with Miyagi University of Education
- 3). President of CAPEU asked the Secretariat to contact possible donors for the training.

4). At the end of this session, the Secretary of CAPEU asked the Secretariat to contact IMT-GT and develop cooperation with this regional program since Malaysia is now the Secretariat of ASEAN, either for research or other education programs.

#### 8.0 THE SEVENTH BOD OF CAPEU

Since BoD should be executed twice a year, the President of CAPEU suggested that the Seventh BoD be conducted in Indonesia, though the original plan for the venue should be in Thailand. Since Thailand was not represented by any representative, it was proposed that it should be conducted at Universitas Sriwijaya in Palembang. The proposed date will be August or September 2015.

All members attended the Sixth BOD agreed on the proposed estimated time. He asked the Secretariat to develop further contact Universitas Sriwijaya for exact time and venue and inform all members.

Prof. Ari Purbayanto suggested that all quality assurances that deal with education in each country or region conduct a special meeting on Quality Assurance for Teacher Training. Please invite BAN PT from Indonesia, MQA in Malaysia, TTA of Australia, NIE in Singapore and similar institutions from Hong Kong to share experience. President of CAPEU and the Secretary of CAPEU, followed by all members agreed on the proposed ideas and concept.

### 9.0 THE THIRD CAPEU INTERNATIONAL CONFERENCE

The President of CAPEU proposed that The Third CAPEU International Conference should be in the Philippines and be conducted by the Philippine Normal University (PNU) in Manila. The PNU will be the host.

- 1). Many agreed that the conference be conducted in the Philippines and hosted by PNU.
- 2). Secretary of CAPEU requested that PNU proposed date for the Conference.
- 3). The President of CAPEU suggested that it should be at the end of the year (2015). The President of PNU suggested that it should be conducted in February 2016.
- 4). The topic for the conference is "Diversity in Education".
- 5). Prof. Noor Shah (Treasurer) of the BoD said that CAPEU will pay two persons from each member of CAPEU; registration fee, two-day accommodation on twin sharing basis, and lunches during the conference.
- 6). Finally the floor approved that the Third CAPEU Conference will be at PNU and will be in February 2016.
- 7). The Secretariat of CAPEU assigned the Secretariat to develop contact with PNU to make good preparations for the conference and report to the BoD of CAPEU and all members in member countries.

### 10 REPORST ON SECOND CAPEU INTERNATIONAL CONFERENCE

The President of CAPEU requested Dr. Hj. Adenan bin Hj. Basar to provide a brief report on the Second CAPEU International Conference in Brunei Darussalam. Dr. Adenan asked Dr. Humaizi bin Samion, KUPU-SB CAPEU Division to report. The following is a brief report for the conference:

- 1). It was conducted from 24-25 November 2015.
- 2). It was almost fully sponsored by the Government of Brunei, through the Ministry of Religious Affairs of Brunei Darussalam.
- 3). Presented 70 papers by more than 70 presenters since some of the papers were presented by more than one presenters.
- 4). Participated by 250 participants from members of CAPEU.
- 5). 50 participants from teachers in Brunei Darussalam
- 6). As many as 20 participants are from KUPU-SB.
- 7). Dr. Hj. Adenan proposed that University Brunei Darussalam (UDB) is invited to be a member of CAPEU. He has talked to the management of UDB, especially the Brunei Institute of Education (BIE).
- 8). President of CAPEU asked the Secretariat to take action.

#### 11. CAPEU FINANCIAL REPORTS

The President of CAPEU asked the Treasurer of CAPEU to give brief reports on Financial Condition of CAPEU. Prof. Noor Shah, the Treasurer of CAPEU presented his reports:

- 1). He asked each member attended the BoD to look into the Yellow/Orange pages of the Financial Reports.
- 2). He said that the Report has been reviewed by the Treasurer of the UPSI since all fees received from members are banked in the official account of UPSI. It is verified periodically by UPSI.
- 3). Prof. Fuad Abdul Hamid asked the floor if there are any statements in the MoU on the quorums of attendance for the BoD to approve this report.
- 4). President of CAPEU and Prof. Mohd. Izam said that there are not any statement on such a thing since it is very difficult to gather all presidents/rectors/chancellors or vice chancellors at one time to attend BoD.
- 5). Both of the above key members of CAPEU said that there are a lot of hindrances if we tied ourselves up with such a statement. The President of CAPEU said that today several rectors from Indonesia could not come due to not having their visas approved, due to having election to elect the new rectors and other reasons.
- 6). After giving a time to review, the President and the Secretary of CAPEU asked the floor if there are any comments on the reports.
- 7). The floor did not received any comments or critics and finally approved the Financial Reports.
- 8). The treasurer said that there still more than RM 100.000 in the account of CAPEU till March 2015. There are still some more bills to be paid between April and May 2015.

- 9). The treasurer also said that most of the fees were paid late by members and some are not in full RM 10,000.00 as stated in the MoU. The first to pay was UPSI, paid a week after the establishment of CAPEU. Only four other universities paid between September 2013 and December 2013. Therefore, we could not conduct many activities.
- 10). We also make some saving due to the generosity of the sponsors, such as the Governor of Aceh, the Government of Brunei Darussalam and other sponsors for our conferences in Aceh and Brunei Darussalam.
- 11). The Secretariat of CAPEU said that we have to do the same when we conduct our Third CAPEU Conference in The Philippines. We do hope that PNU work hard to get more sponsors, especially the local government.

MINUTES OF ANNUAL GENERAL MEETING
AND
BOARD OF DIRECTORS' MEETING OF CAPEU

At DEAKIN UNIVERSITY, MELBOURNE, AUSTRALIA

#### 1. ELECTION OF NEW BOD OF CAPEU

#### 1.1 Welcoming Speech from the President

The President of CAPEU welcame all members of BoD of CAPEU that attended the session. He said that his two-year term as the President of CAPEU, as regulated in the MoU, has already expired and now it is time for other members to lead. It can be by one of the member from Malaysia, Indonesia, Deakin, Thailand, and Brunei Darussalam. Please feel free to propose a university as a member first and then followed by the leader of that university member.

Prof. Dr. Mohammad Izam of UUM proposed that Prof. Dr. Ir. Ari Purbayanto, Indonesian Education Attache to Malaysia chair this session. The first reason, he said that he is an honorary member of the BoD of CAPEU. Secondly it will be fair and more independent if it is not chaired by any member of CAPEU. The Secretary of CAPEU supported the proposal from UUM and followed by the President of BOD of CAPEU and other members.

Prof. Fuad Abdul Hamid from UPI once again asked: "If the quorum is not enough, will the results of the election be acceptable?". Many of the members said that it was not stated with the reasons that we had discussed previously when discussing the Financial Report.

#### 1.2 Election of New BoD for the Second Term

Prof. Dr. dr. Badia Perizade, Rector of Universitas Sriwijaya said that CAPEU is still a half-boiled egg, please allow UPSI to continue to lead for another term. Her statement was supported by UUM, Deakin University, PNU and also the Indonesian Education Attache. - 2). Prof. Dr. Mohd. Izam from UUM said that, though still young CAPEU has been doing good job and suggested that at least to maintain as it is. However, more programs can be done when all hands are put together by all members and also supported by the partners.
- 3). Prof. Fuad Abdul Hamid of UPI said UPI appreciates what CAPEU has been doing though within a short period of time. Please develop better cooperation between members.
- 4). Prof. Badia, it is a half-boiled egg, keep the egg boiling till it is well done. I will be no more rector of Sriwijaya University within the next few months. My next Rector will support the program. I may be able to see you all again if the Seventh BoD of CAPEU be conducted by August or September this year.

#### 2. CLOSING THE ANNUAL GENERAL MEETING

#### 2.1 Farewell Speech by the Host

As the host for this Roundtable Meeting and the Sixth BOD Meeting, and as the Deputy President of the CAPEU, Prof. Dr. Ian Robottom thanked all members that attended the meeting and hope to see all of them within the next few months. However, he proposed that Dr. Christ, the Dean for Research of the Faculty of Education of Deakin University be included as one of the committee members in the new management of CAPEU. The main reason is that he will be no longer full time staff by July this year and Dr. Christ will be supporting him to carry on programs of CAPEU.

For UPSI-Deakin Symposium and for any collaboration with other members, he also proposed that Assoc. Prof. Dr. James Campbell be appointed as one of the committees representing Deakin in the management. He is well-known in South East Asia and very knowledgeable for the region. The two proposals from Prof. Robottom were accepted by all members.

#### 2.2 UPSI-DEAKIN Symposium

Early discussion was conducted a day prior to the Sixth BoD Meeting between Assoc. Prof. Dr. James Campbell, assoc. Prof. Dr. Qismullah Yusuf, Prof. Dr. Amir Hasan Dawi (Dean of the Faculty of Education) and Assoc. Prof. Dr. Noor Shah Saad for UPSI-Deakin Graduate Research Symposium. After having another meeting between Prof. Dr. Ian Robottom and Dr. Christ (Associate Dean of the Faculty of Education of Deakin University) and The Secretariat of CAPEU, it was concluded this Graduate Research Symposium is important.

The results of the First and Second Graduate Research Symposium between UPSI and Deakin University have been appreciated by the academicians, not only by the academicians within the two campuses but also by many teachers teaching around UPSI campus in Malaysia. Some of

the participants for the Second Symposium were from other states in Malaysia and few of them were from Indonesia and Thailand.

The final decision is to continue having this Graduate Research Symposium conducted between the two universities. The Third Deakin-UPSI Graduate Symposium will be conducted at Deakin University on the basis of reciprocality between the two universities. The Fifth one will be conducted at UPSI at the end of 2015.

#### **ROUNDTABLE MEETING**

11-12 May 2015

Deakin University City Campus, Melbourne

#### 1. WELCOMING SPEECH

The Roundtable meeting was started with a short speech of Prof. Robottom, followed by the introduction of Prof. Dr. Christine, the Dean of the Faculty of Education and Deakin University. Prof. Robottom said that it was a good combination where BoD of CAPEU was combined with the Roundtable Meeting on certain academic aspects of concerns of members of CAPEU, especially current trends and issues on education, issues and problems facing by member countries.

#### 2. FIRST PRESENTATION (DEAKIN)

The First Presentation was delivered by Prof. Dr. Christine, the Dean of the Faculty of Education of Deakin University. Her presentation was focused on the system of education that have been practiced in Australia and efforts that have been done to improve the quality of education of her country. She further emphasized that Australia, in addition of its own, also seek other strengths from other countries, such as Canada and several European countries, to improve the quality of education in her country. She also said that each state in Australia has its own policies, however, it also based on the national guidelines provided by the Federal Government.

### 3. SECOND PRESENTATION (UPI BANDUNG)

The second presentation was delivered by Prof. Dr. Ace Suryadi, presenting how UPI was involved in shaping the national policies of teacher training to be developed by the Ministry of National Education of Indonesia. Indonesia, he said is still in the process of seeking other alternatives or choices to further improve the quality of teacher training in Indonesia. UPI or Indonesia as a whole is willing to cooperate with other institutions and other countries to improve her education.

Indonesia has been working with NIE in Singapore and other several institutes in several other countries. One of the main problems, he said, that the policies and programs of teacher education at the higher institution are not always in line with the policies made by the local department of education (district and province). The Ministry would like to improve the quality of education but at the same time it keeps issuing "permits" for private sectors to open new teacher training institutions without proper facilities and labs for teacher training. In recruiting teachers, the BAKN is setting other policies by keeping appointing the graduates of low quality teacher training institutes and the number is quite high every year.

#### 4. THIRD PRESENTATION

Prof. Dato' Dr. Noraini Idris, the Secretary of BOD of CAPEU presented her paper on the current researches being conducted by UPSI in improving the quality of teacher training programs at Malaysian universities.

#### 5. FOURTH PRESENTATION

The Fourth Presentation was delivered by Prof. Dr. Ari Purbayanto and Qismullah Yusuf on the importance of Providing education to the school-aged children in Sabah and Sarawak. There are more than 60,000 school-aged children in the two eastern states of Malaysia. They are trapped in between the problems: no teacher to teach, no facilities to support and no administrative support s from the home and the new home where they were born (Malaysia). The negotiation has been for so long and no solutions are yet to be found between the two nations. CAPEU is proposing that all members from Indonesia and all members from Malaysia work together and use "teaching practice" courses to initially solved the problems prior to having a permanent solutions being negotiated between the two nations.

## 6. PEACE EDUCATION IN SOUTHERN THAILAND

Fatony University is a member of CAPEU. The political conflict in Southern Thailand has been there for more than 20 years. It needs to be solved as soon as possible to save life and be able to proceed and improve the quality education in the six southern provinces. CAPEU is not a political organization but an organization that cares for education of all school-aged children. Prof. Dr. Fuad Abdul Hamid, a senior professor in Anthropology from UPI presented the paper to seek possible answers to the problems in the regions.

He has been involved in setting peace education classes at UPSI as the results of training provided to him and other senior lecturers at UPI by Finland, Sweden and other European countries. One of the solutions proposed by Prof. Hamid was that there should be a steering committee between members of CAPEU to design acceptable peace education curricula to be used by education and social institutions in Southern provinces of Thailand. Proposing peace through the mind and use education as a tool will be more sustainable for both sides, the Government and also the opponents. He said that Indonesian some of flatforms can be used as a model in solving a conflict.

Exchange programs in the form of reciprocal seemed to be preferable by members of the consortium. As many as 32 students from UPSI, for instance, were sent to the Center for Risks Reduction Management (CRRM) at Syiah Kuala University in Banda Aceh to learn how to manage an evacuation center when a disaster happens. These students were trained not only by the CRRM but also by the National Search and Rescue Office of Banda Aceh. It is reported that many of these students participated in emergency programs provided by Malaysian Government when handling severe flood in six states in Northern Malaysia.

The first workshop on Special Education was conducted in Banda Aceh with the facilitators provided by the DAAD in Jakarta and Deakin University in Australia. The second workshop on Mapping program was conducted between members of the consortium to formally exchange programs reciprocally between members. The third workshop was conducted at the Universitas Pendidikan Indonesia in Bandung to write a formal proposal to be submitted to the Ministry of Education of Indonesia for providing education to the 63,000 school-aged children of Indonesian migrant workers in Sabah and Sawarak, Malaysia. The fourth workshop was conducted at Deakin University for developing the quality of teacher education among members of the consortium. The fifth workshop will be conducted at the Universitas Negeri Yogjakarta on Disaster Awareness, Preparedness and Management.

The partner schools of UPSI have started their reciprocals program through CAPEU. Kuala Kubu Baharu MARA High School, a partner school of UPSI in Selangor, sent 32 students to Fatih Bilingual School and Syiah Kuala Lab School in Banda Aceh. These students were merged with the students from the two schools in Banda Aceh and exchanged academic matters and cultural experiences between the students from the two countries. Semarang State University has been sending its students to UPSI for the last two years. Similar exchange programs have also been conducted between UUM and members of the consortium in Indonesia.

#### 3.1 Students' Exchanges

Students' exchanges programs that have been taken placed between Sultan Idris Education University (SIEU) - Syiah Kuala University (SKU) in Banda Aceh and Indonesia Education University, formerly known as IKIP Bandung, have been highly appreciated by students and faculty members of both countries. They have gone through academic and cultural exchanges during the last five years. Similar students' exchanges can be developed among members of consortium and with partner universities outside the consortium and among members of the consortium. UPSI and Syiah Kuala University have also conducted students' exchange program in disaster management where 32 students from UPSI were sent to Aceh for training.


#### 3.2 Faculty Exchanges

The Sultan Idris Education University (SIEU), Syiah Kuala University (SKU), Sriwijaya University and Indonesia Education University (IEU) in Bandung have gone through several phases of faculty exchanges during the last three years after the first MoUs were signed between the three universities. Such exchanges will ignite research collaborations and establish dual/double degree programs between member universities and with partner universities. The first joint publication between SIEU and IEU was published and launched last September in Kuala Lumpur. Faculty exchange has also been conducted between Syiah Kuala University and UPSI.

#### 3.3 Dual/Double Degree Program

Student and faculty exchanges and sabbatical programs will also be initial steps in establishing dual or double degree programs within the member universities in the consortium. New departments of a member university can request help from stronger university in certain areas of studies to improve the quality of its training and education services to meet the needs of more qualified lecturers/professor for a member country/university in certain areas of studies.

Deakin University in Melbourne, Australia has developed double degree program in EFL with Syiah Kuala University in Banda Aceh and as many as 45 Master's degree students in EFL have graduated from the university and are now serving the needs of EFL teachers in Aceh. Almost 100 teachers of Aceh, pursuing their Master's degrees in Science and Mathematics Education have completed their degrees at Deakin University. They are now improving the quality of Modelling High Schools in the province. Similar programs can be developed with other universities in the consortium and with other partner universities in other member countries.



#### 3.4 Joint Research and Publications

In addition to establishing collaborations as mentioned above, the consortium will also develop cooperation with member universities in conducting joint researches to be funded bilaterally or trilaterally between the core members and also with other party interested in the projects. Taiwan universities are known for their publications and quotations during the last ten years. Universities in Taiwan can be approached to develop this types of collaboration. To enable the consortium in managing the joint research and publications there should be a committee established by the consortium and appoint a country/university/ institution to manage all researches and publications written by faculties from members of the consortium, partner universities and

The best students in their final year (the fourth year for undergraduate) in selected areas of studies will be selected and sent to SIEU and other members in Malaysia to pursue one semester for course works, preferably in the last two semesters of their programs. After completing the first semester in their last year, these students will be assigned to teach for a period of 12 months in Malaysian estates and mega projects and returned to Indonesia with dual degrees through the agreed transfer credits between SIEU and Indonesian education universities. Similar programs can be made for Master's degree programs.

The main obstacle in coping with the above problem is "visa" for Indonesian teachers to be sent to Malaysia. By developing a dual degree/double degree or transfer credit programs with SIEU and other Malaysian members, the visa can be assisted by Malaysian universities and Indonesian teachers can be sent to Malaysia to provide education to many "unreachable learners" of Indonesia in Malaysia under the supervision of both; Malaysian universities and Indonesian universities. The program can be carried out in two forms:

#### (1) KKN-Like Mode

The first program is called Kuliah Kerja Nyata (KKN), an internship program in Indonesian higher education system in which every student is compulsory to conduct a real community services for duration between 4 to 6 months in the fields prior to having diploma awarded to a student. This program can be implemented when there is a partner/member university in Malaysia that is willing to register Indonesian students (undergraduate degree) to take a semester or a year at a Malaysian university and conduct 12-month practicum to provide compulsory education to more than 63,000 school-aged children and many Malaysian plantations/estates legally in any state in Malaysia. The budget for Indonesian students to be sent to Malaysian plantations/projects may be paid by Indonesian government and all legal documents for the program will be handled by a Malaysian universities.

#### (2) Formal Teaching Services

The second proposed program will be through formal attachments/services to be conducted by Indonesian/Malaysia education university graduate students. These students are to be awarded scholarships (from Indonesian Government) to pursue their Master's degree programs at a Malaysian education university for duration of 3 semesters; one year for their course works at a Malaysian university and another 12 months for their teaching practices to teach the 63.000 school-aged children of Indonesian migrant workers at Malaysian estates in Sabah and Sarawak and other states in Malaysia. Programs are now being designed between institutions in Indonesia to solve the problems in having basic education to Indonesian pupils in Malaysia.

Similar cross-border programs can be developed between other member countries in the consortium. There are also children of migrant workers from Thailand, Myanmar, the Philippines and other countries in Malaysia. It will benefit the cross-border countries and solve parts of the problems sooner.

#### 3.8 Professional Teacher Training Program

The members of the consortium can also develop joint training programs to train teachers, principals, school administrators, and other professions related to education at any member of the consortium in which trainers are selected from professional staff from members of the consortium. Through MoU signed between Government of Aceh and SIEU, for instances, two batches of math and science teachers and principals of modelling schools from Aceh have been trained by UPSI (with venues in Aceh and Malaysia) without taking any profits. The trainings were conducted on the basis of "CSR-corporate social responsibilities" of the Sultan Idris Education University.

#### 3.9 Professional Attachments

As it is with the training programs, "attachment" is another important program that can be developed in developing, improving and widening horizons of education and training management in each member of the consortium. The attachment can be at each member of the consortium or arranged by each member at each

students to participate. The fees for students who will present their papers at the conference will be reduced or may be waived. The key-note speakers for this conference were donated by DAAD, Deakin University and Sultan Idris Education University.

The Second seminar was conducted at the Kolej University Perguruan Ugama Seri Begawan in Brunei Darussalam, sponsored by the CAPEU, the Ministry of Religious Affairs of Brunei Darussalam and the Ministry of Education of Brunei. The Third conference will be held at the Philippines Normal University in Manila, the Philippines. The topics will be Education in Diversity and the key-note speakers will be donated by Deakin University, Hong Kong Institute of Education and Miyagi University of Education.

#### 3.13 Automatic Credit Transfer

All transcripts of all members of universities must be translated into English and these credits are transferable between members of consortium except for subjects related to state ideology, philosophy, religion and local contents. This agreement is valid for undergraduate and graduate levels of studies. Members of the consortium must have similar course descriptions of core courses offered by members of the consortium and approved academically and administratively by member universities. In addition to course descriptions, member universities should also approve "credit loads" of each subject/course offered by members and transferable with similar credit values.

#### 3.14 Reduction of Accommodation Cost

Should students from members of consortium pursue their programs outside of their own campus, the host campus must charge students of members of the consortium with "local rate" to increase higher degree of exchange between students of members of university. Through this agreement, even students without scholarships may be able pursue their degrees at any faculty/program outside of their own original university in member countries.

#### 3.15 Diploma Accreditation

Diplomas issued by each member university will be accredited through systems of each member countries. There should be a system developed jointly by related ministries in each country in which diplomas (undergraduate, graduate or other forms of formal degrees) are officially accredited. This system will convince higher rate of student and faculty exchanges between members of the consortium.

#### 3.16 Sabbatical Leave Program

Assoc. Prof. Dr. Jane Teng Yan Fang, a faculty member of the Faculty of Economics and Management of Sultan Idris Education University had returned from East-West Center in Hawaii and now resume her teaching at her faculty. Assoc. Prof. Goh Swee Chee just returned from Deakin University after spending almost 9 months sabbatical leave at the university. Assoc. Prof. Dr. Siti Eishah Moekhsien is now at Deakin University conducting her sabbatical leave for the same period as Dr. Goh. Dr. Ikhsan from FPPM is now at Syiah Kuala University conducting his Sabbatical Leave at the university. He will be there for a period of 6 months. Similar programs are now being developed with DAAD in Germany and Miyagi University of Education in Japan. The program can also be developed among members or partners of the consortium.

Assoc. Prof. Dr. Mohd. Uzi bin Dollah will be leaving for Deakin University conducting his sabbatical leave at the university. He will be developing the concept of "mathematical values" in teaching mathematics together with a professor of mathematics at Deakin University. An associate professor from the Faculty of Languages and Communication of UPSI is planning to conduct her sabbatical leave at Deakin University where she will, not only working for her sabbatical leave, also be co-teacher for teaching Mandarin Language at Deakin University.

The visit was intended to develop special ties with this university in South Celebes Island. One of the plans was to develop a transfer-credit program between the two universities between FEHD of UPSI and the Faculty of Education of Makassar State University. This was planned to be a model and will be duplicated between other members of CAPEU. It was a delay due to having new regulations from UPSI and it will be implemented by the year 2015.

Makassar State University can also develop this transfer credit programs with Universiti Utara Malaysia in Sintok, with the Universiti Islam Antarabangsa Malaysia and other universities in Indonesia.

#### 9). Visiting Malikussaleh University (January 2014)

The team from CAPEU, consisted the Dean of the Faculty of Education and Human Development and met the Rector, all deputy rectors and all deans of Malikusaleh University. The purposes were to discuss possible collaboration with the university and the mayor of the City of Lhokseumawe, Aceh, Indonesia for sending its students to members of CAPEU for degree programs. Malikussaleh university is a member of CAPEU.

#### 10). Visiting Syiah Kuala University (January 2014)

The visit was made by the Dean of the Faculty of Education and Human Development of UPSI, accompanied by the Deputy Dean for Research and Innovation of the faculty met the Rector and Dean of Faculty of Education and Teacher Training of Syiah Kuala University on the request of Deputy Governor of Aceh for provided possible assistance of UPSI to start Special Education Program in Aceh for preparing and or replacing special education teachers for Aceh since many of their teachers were dead or missing in the December 26th, 2004 tsunami.

#### 11). PCK Training for teachers in Aceh Besar (February 2015)

On the request of the Mayor of Aceh Besar, CAPEU sent Assoc. Prof. Dr. Qismullah Yusuf (UPSI) to conduct a one-day Seminar on Pedagogical Contents Knowledge (PCK) for teachers in Aceh Besar District. It was participated by about 40 teachers and 120 students of the Prof. Ali Hasymi's Modelling High school in Sibreh, Aceh Besar, Indonesia.

#### 12). Visit Makassar State University (March 2014)

The purpose of this visit was to discuss Dual Degree Programs between UPSI and Makassar State University in the areas of Psychology, Guidance and Counseling, Special Education and Early Childhood Education. The team met the rector, deans and heads of departments of the university. The visit will be implemented by the end of this year. Detailed discussions are being done between the two universities.

#### 13). Visit Dinas Pendidikan Aceh (March 2014)

The team of CAPEU met Drs. Anas Muhammad Adam, M.Pd, Head of Department of Education of Aceh, for possible collaboration between the Department of Education of Aceh and UPSI in teaching teachers, the training of the principals of lab schools and education administrators. The programs were successfully conducted from July – September 2014 where almost 300 teachers of Aceh were trained at UPSI.

#### 14). First Deakin-UPSI Graduate Symposium (March 2014)

It was a three-day seminar, a Reciprocal Graduate Symposium Program between Deakin University and UPSI. As many as 22 Graduate students from UPSI were sent to Deakin to participate. Deakin reciprocally provided

#### 19). Finalizing Training Program for Aceh (29 April 2014)

The meeting was conducted at the FPPM of UPSI with the team from the Government of Aceh. The purpose of the meeting was to discuss possible collaborations between FPPM and Department of Education of Aceh for sending Principals, Math and Science teachers and Vocational & technical Teachers to be trained at UPSI in the areas of pedagogy, contents, ICT and school management. In implementing the program, Aceh also sent school superintendants to be trained at UPSI and facilitated with school visits to several schools in Malaysia.

#### 20). Facilitating Members with other Networks in Malaysia (30 April 2014)

The team from The Government of Aceh, the Department of Education of Aceh and Syiah Kuala University visited the SEAMEO-SEN in Malacca. CAPEU Office at UPSI provided assistance by taking the guests from the three institutions from Aceh to meet Director of SEAMEO-SEN for possible Collaborations between Syiah Kuala University — UPSI and SEAMEO-SEN. Several programs have now been implemented between Department of Education of Aceh, Syiah Kuala University and SEAMEO-SEN Malaysia.

#### 21). Preparation for Second CAPEU International Conference (2 May 2014)

CAPEU Office received guests from the Kolej University Perguruan Ugama (KUPU) consists of Dr. Adenan bin Haj Basar, Deputy Rector for Academic Affairs of KUPU and Dr. Hunaizi Samiun (Special CAPEU staff of KUPU) for the preparation of the Second Conference in Brunei Darussalam.

### 22). Meeting with Head of Department of Education of Sabang (30 May 2014)

The head of the Department of Education of Sabang was welcome by Assoc. prof. Dr. Rosnidar Mansor, the Deputy Dean for Research and Innovation of the FPPM UPSI and had a long discussion on the possibility of training 200 teachers of mathematics, English and sciences and about 50 principals and education administrators in Sabang. The training should be conducted at Sabang and the trainers are from UPSI. The programs were given to the FPE UPSI for further communication with the head of Education Department of Sabang.

#### 23). ICTL Conference at Ipoh (26-27 May 2014)

This conference was a conference initiated by the Faculty of Education and Human Development of UPSI. However, in order that the conference be provided with international keynote speakers, CAPEU was asked to invite reputable keynote speakers for the conference. The Dean of the FEHD of UPSI requested help from CAPEU to invite keynotes speakers from partners of CAPEU since the conference will be also participated by many of participants from member universities of CAPEU from Malaysia, Indonesia, Brunei Darussalam, Thailand and several other countries in South East Asian nations. The followings are keynote speakers donated by partners of CAPEU:

- 1). Dr. Namji Steinemann, provided by East-West Center in Hawaii in the USA
- 2). Prof. Dr. Tomonori Ichinose from the Center of International Understanding on Education of Miyagi University of Education.

The conference was held in Ipoh, Perak and participated by more than 500 participants. Several workshops were also conducted during the conference.

#### 24). Providing free half-day seminar to Teachers of School in Ipoh (27 May 2014)

In addition to giving keynote speaker, UPSI also request Dr. Namji Steinnemann, the speaker from East West Center to give special lecture to Special Education School in Ipoh. It was participated by all teachers at the

universities. Many of students who presented their papers at the symposium had shown their leaderships in managing the audiences and in maturing their presentation experiences at the symposium.

### 30). The Second Conference on Teacher Education (23-24 November 2014)

The conference was hosted by KUPU in Brunei Darussalam and sponsored by the Ministry of Religious Affairs of Brunei Darussalam and the Ministry of Education of Brunei Darussalam. It was officially opened by the Ministry of Religious Affairs and officially closed by the Ministry of Education of Brunei Darussalam. It was a good collaboration between the two ministries.

The conference was participated by almost 500 participants from countries in South East Asian nations in addition to participants from CAPEU Members. A resolution was made by the Conference Committee and presented it the two ministers in Brunei Darussalam.

### 31). The Fourth BoD Meeting at KUPU (November 24, 2014)

The fourth BoD Meeting of CAPEU was conducted at the KUPU (Kolej University Perguruan Ugama) in Brunei Darussalam. It was held at the University Senate Room of KUPU. It was participated by 11 members of the consortium, chaired by the President of CAPEU, the Secretary of CAPEU and the host of the BoD Meeting, Dr. Hajjah Masnon bin Hj. Ibrahim, the Rector of KUPU. The BoD was conducted on November 24, 2014.

#### 32). The Visit to LPDP (November 2014)

As requested by the Vice Chancellor of UPSI, CAPEU designs special programs where scholarships from LPDP can be utilized using normal and regular programs or using special designed program where scholarships of LPDP can be used to send students from Indonesia and pursue their studies at UPSI. However, they must conduct their internships at Sabah and Sarawak to assist the drop outs of school-aged pupils in the two states. This program had been discussed three times between the VC of UPSI and members of CAPEU from Indonesia.

#### 33). The visits of LPDP to UPSI (December 2014)

As from the outcomes of the discussions and meetings, it is agreed upon that parts of the scholarships will be provided for "special scholarships" for Indonesian students where part of the scholarships will be for conducting teaching practices at Sabah and Sarawak.

#### 34). Meeting at Indonesian Embassy in Kuala Lumpur (February 2015).

The Secretariat of CAPEU was invited by the Indonesian Education Attache at the Embassy of Indonesia in Kuala Lumpur. The purpose was to plan, design and implement special scholarships from LPDP and be used for the internships in teaching practices in Sabah and Sarawak. Students from Indonesia will receive scholarships from LPDP but they have to conduct at least 6 months teaching practices in the states.

# 41. Meeting with the Management of Al-Muslem University in Bireuen (August 26, 205)

This private university is the second oldest university in Aceh, established in 1928 by a leading hulubalang in association with Muslem scholars during the Dutch Colonial Government. The university has 17,000 students with about 1,000 teaching staff and administrative staff. The faculty has 6 faculties with 41 study programs. It is located about 240 km to the east of Banda Aceh. This university is interested in developing collaboration with members of CAPEU in Malaysia through UPSI.

# 42. Meeting with the Rector of STAIN Gajah Puteh in Takengon (August 27, 2015)

As the only state university in Central Aceh, this university is also interested in developing collaborations with members of CAPEU in Malaysia for improving the quality of Teacher Training Programs at the University. This university is also interested in developing ties with Deakin University to develop the quality of its English Education Program to improve the quality of English education in the five district nearby the university. Fifteen of its teaching staff are the graduate or UPSI and Deakin University.

### 43. Meeting with the Director of STKIP Bina Bangsa (August 29, 2015)

This is the only Sekolah Tinggi (Higher Institution) that is interested to sign an MoU with CAPEU. This institute will be developing its collaboration with members in Malaysia and also with Deakin University since most of the teaching staff members are the graduates of UPSI, UM, UUM and Deakin University.

#### 44. Meeting the Wife of the Governor of Aceh (August 29, 2015)

This First Lady of the Province of Aceh is planning to upgrade the quality of early Childhood education in her province by collaborating all kindergarten in the Capital City of the Province with the National Child Development Research Center at UPSI and with other members that have programs in Early Childhood Education. A group of 32 principals of kindergarten from the province will be visiting NCDRC at UPSI to develop formal ties with UPSI and other members of CAPEU.

# 2.Call for Papers and Pre-Registration

a. The oral and poster presentations will be open to all graduate students and faculty members of CAPEU and of the other countries.

b. The abstract of the paper related to multicultural education

shall be composed of 350 words.

c. The secretariat will accept abstracts starting August 28, 2015 until October 26, 2015.

d. The pre-registration can be done online and on-site.

# 3. Review and Evaluation of Research Abstracts

a. There shall be a committee to be composed to review and evaluate the submitted abstracts. They shall screen the abstracts which will qualify for a 15-minute oral presentation or an hour-long poster session.

b. The review and evaluation of submitted abstracts for oral and poster presentation will be done on November 9 to December 9, 2015. For full paper, review and evaluation shall be on December 18, 2015 – January 18, 2016. The list qualified presenters will be released by January 22, 2016.

# 4. Preparation for the Conference and Evaluation

a. The committees and secretariat shall coordinate regarding the venue, program of activities and other schedules during the two-day research conference.

b. The evaluation committee will be in charge of the monitoring

and evaluation of the conference.
